



Authors must recommend at least five potential reviewers, who are
experts in the field, at the time of submission of an invited review. Manuscripts are peer reviewed, and final acceptance is contingent upon satisfactory response by the author to the reviewers' comments. Scope of the Journal Articles for Chemical Reviews
should be substantial, comprehensive, authoritative, critical, and accessible reviews of published results on recent topics in chemistry that have not been comprehensively and critically reviewed in the past three to four years. Reviews may cover either mature or emerging areas of research, but not inactive areas. Reviews of general interest and with
high potential for broad impact are preferable to narrowly focused ones. The author should be a recognized expert in the field, and the scope of the subject should be considered when selecting material for discussion, although not all will be treated in
depth, and the author's own work should not be singled out for emphasis. The presentation should be addressed to readers who are comprehensive in the treatment of the subject matter within the scope defined in the Introduction, but comprehensive
does not necessarily imply a specific length or style. Reviews should provide a critical analysis of the topic and insights about the remaining challenges and future directions for the field. Manuscript types A typical Chemical Review is described above under Scope of the Journal. The Focus Review is a special type of manuscript that is distinct from a
regular review because it is more concise and forward looking and typically addresses a rapidly evolving topic. These types of reviews must still retain the key characteristics associated with Chemical Reviews. Specifically, a Focus Review must be comprehensive within the scope defined in the Introduction, even if this scope is relatively narrow, and
should not single out the author's own work for emphasis but rather should consider all significant contributions to the field. It must also contain a critical analysis, as well as a discussion of remaining challenges and future directions. A Focus Review should be no longer than 20 published pages, which corresponds to approximately 60 double-spaced
